## The Illegal Alien Crime Reporting Act of 2011 Remembering the American Victims of Illegal Alien Criminals

[FIRE Coalition](#), in partnership with the [Tea Party Immigration Coalition](#) and the [Foreign National Crime Information Center](#), will hold a press conference in Washington, D.C., Thursday, November 3<sup>rd</sup> to support Congressman Walter Jones' (NC-3) [H.R. 3168, The Illegal Alien Crime Reporting Act of 2011](#), and to designate November 6<sup>th</sup> as The National Day of Remembrance for the Victims of Illegal Aliens. We thank Congressman Steve King (IA-5) for introducing a House Resolution naming November 6<sup>th</sup> as "The National Day of Remembrance for the Victims of Illegal Aliens."

"November 6<sup>th</sup> is the 25<sup>th</sup> anniversary of the 1986 Immigration Reform and Control Act Amnesty," said John Stahl, Chairman of the Tea Party Immigration Coalition. "One legacy of the IRCA amnesty is millions of illegal aliens who continue to invade our country expecting another amnesty and some of them are violent criminals. It is appropriate that November 6<sup>th</sup> be the day that we observe a moment of silence, remembering the tens of thousands of unnecessary victims of illegal alien crimes. They are 'unnecessary victims' because if the federal government did its job, secured our borders and enforced our immigration laws, we wouldn't have illegal alien criminals victimizing innocent American citizens and legal immigrants."

"Currently, there is no way to determine the actual number of victims of illegal alien crime," said FIRE Coalition National Director Jeff Lewis. "The March, 2011 GAO report on [Criminal Alien Statistics](#) only hints at the problem. Congressman Jones' legislation is not an 'immigration bill,' Lewis concluded. "It's a crime bill, and one that's long over due."

The Foreign National Crime Information Center's Victims of Illegal Alien Crime Memorial ([VOIAC.org](#)) has a database of victims of illegal alien criminals. The public can also submit new 'unnecessary victim' entries.

FIRE Coalition is pleased to partner with Tea Party Immigration Coalition, The Foreign National Crime Information Center, and all Congressmen and patriots who desire to make America safer by forcing our government to secure our borders and enforce our laws. ## BACKGROUND:

In 2007, [Family Security Matters](#) contributing editor [Peter Wagner](#), author of "[The Dark Side of Illegal Immigration](#)" queried the Justice Department and Federal Bureau of Investigation (FBI) with a simple question.

"Why don't you track illegal alien crime?" The Justice Department's answer? **"Congress hasn't told us to."**

On October 12, 2011, in the wake of the foiled plot to assassinate the Saudi Arabian and Israel Ambassadors, Congressman Walter B. Jones (NC-3) introduced the "**Illegal Alien Crime Reporting Act of 2011**," (IACRA)

Former Speaker Nancy Pelosi refused to allow this bill to have any hearings or a vote in the 110<sup>th</sup> & 111<sup>th</sup> Congresses. Rep. Brian Bilbray, (CA-50) Chairman of the House [Immigration Reform Caucus](#) and Rep. Dana Rohrabacher (CA-46) signed on as original co-sponsors of H.R. 3168, "The Illegal Alien Crime Reporting Act of 2011."

House Speaker Boehner has referred "The Illegal Alien Crime Reporting Act of 2011" (H.R. 3168) to the Committee on the Judiciary, and Committee on Homeland Security.

## Why Is the Illegal Alien Crime Reporting Act of 2011 Necessary?

*"Open borders and mass illegal immigration were central to Osama bin Laden's plans to invade the U.S. and commit mass murder. These same open borders and continued mass illegal immigration have set the stage for continued crimes committed by criminal illegal aliens against the American public.*

**The Illegal Alien Crime Reporting Act of 2011 would change this by:** [\(Read proposed bill here\)](#)

- requiring states to submit in-depth statistics on illegal alien criminal activity in order to receive Department of Homeland Security (DHS) funding; and
- requiring all federal agencies to submit data on illegal alien criminal activity; and
- requiring the Federal Bureau of Investigation (FBI) to compile this information and produce an annual publication – similar to its existing Uniform Crime Reporting – that provides detailed statistics on illegal alien criminal activity.” Jones’ letter stated.

*"A 2010 FIRE Coalition investigation into a foiled attempt by illegal aliens using stolen or fraudulent identification to gain access to Shaw Air Force Base, home of the Air Force and (new) Army Central Command Headquarters, revealed an alarming statistic," warned Mr. Lewis. ([Shaw Air Force Base Incident Report](#))*

*"What we discovered in our investigation is that over the past five years, no fewer than 727 illegal aliens attempted to gain access to U.S. military, nuclear power, and other sensitive national security installations on U.S. soil. FIRE Coalition has been calling for Congressional hearings into how these critical national security breaches are being handled by the Department of Homeland Security (DHS)." concluded Mr. Lewis.*

To put this in perspective, more Americans have been killed on American soil by foreign national insurgents in the past 10 years than we lost in the Vietnam War, Grenada, Bosnia, Somalia, Desert Shield and Desert Storm, 9/11/2001, and every other foreign and domestic terrorist attack in the past 30 years, **COMBINED!** Congressman Walter Jones believes we must close this gaping hole in our national security.
