Honorable Attorneys General & Fellow Citizens,
You don't have to be a theologian to recall what “30 Pieces of Silver” represents. That is the amount Judas received in payment for betraying Jesus; for betraying a sacred trust. When an elected official fails to uphold his or her oath of office, they too are betraying a sacred trust.

On November 27, 2006 in state capitals from coast to coast, governors, state legislators, and state supreme courts received the FIRE Coalition's “For Whom the Bell Tolls Report.” This report presented to state governments the logical conclusions and facts to substantiate that every day in America, an average of 25 people die at the hands of illegal aliens. With rare exception, none of the leadership of the FIRE Coalition or any of the many organizations partnered with FIRE for the production or distribution of this report was contacted concerning the contents of that report. Various members of Congress and the Senate also received this report and have sat on their hands, totally ignoring an outcry by “we the people.” Some sat on their hands because they find the subject too controversial to address. Others

sat on their hands because they do not believe the problem as described is this bad. Still others simply find it repugnant that citizens have the audacity to make direct contact with elected officials without wringing their hands in servitude. Alas, there is one more group of elected official that did not respond. That is the group of leaders that for a love of money or power are betraying both the American people, and the sacred trust their oath of office embodies.

On January 4, 2007 the 110th Congress convened to take the oath of office. Part of that oath includes a promise, sworn to both God and the American people that they will uphold and defend the U.S. Constitution. One of the Articles of the Constitution guarantees the citizens of every state protection against invasion, namely Article IV, section 4. Nowhere in that oath or in the Constitution does it remotely suggest that protecting the American citizen and the sovereignty of the United States is for sale to the highest bidder. Nowhere in that oath does it suggest that “protection” from the invaders includes waving the white flag of surrender by giving them amnesty, or home loans, or an apartment to rent so that while they are busy raping and pillaging the everyday American they can be more comfortable. Obviously, and ultimately, it is the responsibility of every American to uphold and defend Lady Liberty from attack, be it from a foreign or domestic source.

The House subcommittee on Homeland Security released a report in September of 2006 titled: “A Line in the Sand.” Every citizen and public official needs to read that report. The crisis it speaks to is the invasion of the United States that is taking place at our southern border with Mexico.

Big business interests, many members of Congress, and the President himself in direct betrayal of a trust enjoined between themselves and the American people, are ignoring and not addressing the largest invasion into any country in the history of the world. More than 12 million illegal aliens on American soil is an invasion. It is an undeclared act of war. To talk about amnesty or guest-worker status without first upholding one’s Constitutional obligations is tantamount to treason. Foreign governments, big business interests, and complicit government officials at the federal, state, and local levels are aiding and abetting this invasion. For some, it is through inaction. For others, it is through treasonous actions that undermine both the Constitution and the laws derived from it.

Traditionally, state and local governments have deferred responsibility for protection against invasion to our federal government. There was a time when that deference was both appropriate and well-founded, but not now.

The ability to trust our federal government to act alone in upholding and defending the U.S. Constitution does not seem to exist in America in the 21st century. State and local governments must act in accordance, and within their rights as dutifully elected officials, also sworn to uphold and defend the Constitution, and should exhaust every avenue available to defend and protect the legal citizenry of their states from this invasion.

For the proverbial 30 pieces of silver, elected officials at the federal, state, and local levels are betraying the trust they admitted that they acknowledged as a trust when they took that oath of office. Are you simply ill-informed or are you complicit in this betrayal? If you aren't part of the solution, you are part of the problem. If you are offended or put off by the term "treason" in reference to the actions of elected officials, some recommended reading for all patriotic Americans should make the context perfectly clear. Read the oath of office of the President of the United States, and read the U.S. Constitution. Politically correct jargon will result in the demise of the United States, and the time for that fanciful whimsy has passed. Which type of elected official are you? Do your efforts of upholding and defending the Constitution and the enforcement of America's existing immigration laws as you swore you would do define you as a patriot? Legitimate polling data is clear. The vast majority of American citizens are opposed to rewarding breaking the law. Regardless of political affiliation any elected official that lands on the side of keeping that oath and upholding the Constitution would surely benefit. Talk about becoming a hero or champion of "we the people," it seems a no-brainer to ALL the patriotic Americans. The time is long overdue. The opportunity, regardless of partisan leanings is grand and noble.

Prominent politicians from both sides of the aisle in Congress, including incoming House Speaker Nancy Pelosi from the Democratic Party, and sitting President Bush from the Republican Party, want to give amnesty and guest-worker status to the very group of invaders that are killing 25 Americans every day. Nowhere in the Constitution does it grant elected officials the right or privilege of ignoring their responsibilities to "we the people." In fact, it goes to great lengths in the simplest of words to make it perfectly clear to whom they owe an allegiance. There is no implied or

mandated allegiance to big business interests or to the desires of foreign nationals or their sympathizers found anywhere in the U.S. Constitution.

The FIRE Coalition's "30 Pieces of Silver" report includes yearbook-style photo pages of some of the American citizens who have died at the hands of foreign nationals on American soil. Most of these stories get swept under the rug by the mainstream media. Some, however, are just too outrageous for even them to ignore. Law enforcement officers, women and children, and in some cases multiple members of American families are dying because of the refusal of elected officials to enforce the laws on the books, or to protect the 50 states in this Union against invasion, something Article IV, Section 4 of our Constitution guarantees us.

Consider the following tragedies that occurred just recently...

Thanksgiving weekend: Brian Matthews, a soldier fresh back from Iraq was killed in Maryland by a citizen of another country that was illegally here in America. This illegal alien held a Maryland driver's license he had obtained by turning in a North Carolina license that he should not have had. Did our founding fathers give the British tax stamps, or offer them jobs, healthcare, and loans to buy property? I doubt Mr. Matthews' family will ever look at a head of lettuce in the grocery store quite the same again. Cheap produce, after all, is one of the big arguments sympathizers give to betraying one's country by ignoring our laws and ignoring the mandates of the U.S. Constitution.

Christmas Eve: The Ceran family from Utah was returning from a play when their vehicle was struck by a drunken illegal alien. Six members of the Ceran family were traumatized that night. A mother, Cheryl Ceran, was buried last week as were two of her children, Ian and Julianna. Who should the remaining family members of the Ceran family be able to look to in our government for protection against the invasion that has now taken three special lives from their family? How many generations of the Ceran family will now never exist because our leaders refuse to protect our borders?

New Year's Eve: Deputy Loren Lilly, Cobb County, Georgia died at the hands of a foreign national, an illegal alien allowed to stay in the United States. Upholding the Constitution and enforcing the legitimate laws written from it was Officer Loren's mission in life, now cut short due to the inaction of men and women sworn and empowered to protect even him.

Last Tuesday NBC ran a documentary titled, “Living in the shadow of the American Dream.” Hosted by Tom Brokaw, this documentary attempted to portray patriotic Americans concerned about this invasion as racists, referring to them simply as “Anglos.” NBC attempted to portray an admitted employer of illegal aliens as a victim. This same wealthy contractor benefits twice, first from the cheap labor, and secondly from the added schools and roads he will get to bid on to accommodate the flood of illegals that his aiding and abetting contributes to. An eight month research project by NBC identified a business that hires illegal aliens, showed how these illegal aliens get false documents, and living conditions one might find in third world countries, but not the United States. NBC’s Fleecing of America is documented in the comments section of the NBC Nightly News Blog at MSNBC. Even a poorly enlightened person reading the comments section of this blog will walk away feeling that middle class America is outraged by both the media’s efforts to distort the truth, and the government’s failure to defend our borders. Aiding and abetting is a felony!

If you are an elected official in the United States, and you are not part of the problem, then you should be part of the solution. If you are in business, and are putting your love of money above your duty to country, then you are part of the problem. The American citizenry is fed up with the lies, deceptions, misrepresentations of the truth, and cavalier attitude of those allowing this to happen. We want action, not rhetoric or excuses.

If you aren’t part of the problem, and you take that oath of office seriously, then you are duly sworn and duty bound to look for ways to both uphold and defend the sovereignty of the United States, and to protect its citizenry from invasion.

SOLUTIONS

Incoming House Speaker Pelosi would like to paint patriotic American citizens as lobbyists. Speaker Pelosi, who owns a winery in California that benefits from the cheap illegal alien labor that America’s invasion affords, wants to give amnesty and guest worker status to millions of illegal alien invaders—talk about a conflict of interest. A state’s attorney general in a state is the top law enforcement official within that state. The implementation of policies and the setting of guidelines within a state concerning law enforcement often are born-out by the state’s Attorney General. The FIRE Coalition, comprising groups from coast to coast, feels

that there are pro-active and productive actions the states' Attorneys General should consider when he or she is performing their sworn duty to protect the American citizenry.

Operation Body Count has many faces. It represents the combined efforts of many patriotic citizen organizations across America, working together to educate and inform both the American citizen and the elected official about the loss of life of American citizens on American soil by foreigners that goes unabated, and more often than not, unacknowledged by the very elected officials who are sworn to protect the every day American citizen.

Homeland Security's Immigration & Customs Enforcement (ICE) 287(g) program enables state and local law enforcement to act in some capacities as immigration enforcement officers. The FIRE Coalition is launching a new project that will focus on the benefits of the ICE 287G programs.

Operation FIRE & ICE will endeavor to inform and educate state and local law enforcement agencies and the public about this program.

On Monday, November 27, 2006 while FIRE Coalition members and partner organizations were delivering our "For Whom the Bell Tolls" Report, something special was going on in Charlotte, North Carolina.

Julie Myers, acting head of ICE, and Congressman Sue Myrick were in Charlotte, N.C. to laud the efforts of Sheriff Jim Pendergraph of the Mecklenburg County Sheriff's Office (MCSO). The MCSO has been working with ICE for nearly a year now. Sheriff Pendergraph's team has been able to identify nearly 1,000 illegal aliens just from within the confines of the county jail by using the ICE 287(g) program tools. Both ICE and Congresswoman Myrick praised Sheriff Pendergraph's efforts as a model for others to follow.

In order to avoid some of the concerns of his community, Sheriff Pendergraph as of the end of November had only utilized the 287(g) program tools within the jail walls. There are other opportunities state and local law enforcement would have at their fingertips were they to follow the lead that Sheriff Pendergraph has boldly taken at the Mecklenburg County Sheriff's Office.

On December 6, 2006, the Washington State Director for the FIRE Coalition, Mr. Bob Baker met with his governor's staff. This meeting was agreed to as a result of representatives having seen the first **Operation Body Count** report. One of the proactive results of that meeting was the mutually agreed suggestion that the state highway patrol would be a viable state agency to get involved with the 287(g) program.

The relationship that exists between a community and its local deputy sheriff or policeman is much more personal than that relationship which exists between a community and state or federal law enforcement. A considerable number of illegal aliens that are killing Americans are arrested each day by the state highway patrols in every state. Without access to the ICE databanks and information network via the 287(g) program, they may never know that the person they've apprehended is actually an illegal alien. In our conversations with state and local law enforcement agencies coast to coast, at least among the rank and file there is one predominant complaint, "Our hands are tied," or "We can't do anything, but we'd like to."

The ICE 287(g) program takes the cuffs off state and local law enforcement agencies. It gives the Attorney General an invaluable tool with which to empower the very heroic men and women under his leadership. The FIRE Coalition has approached various members of Congress, Sheriff Pendergraph's office, and Homeland Security concerning **Operation FIRE & ICE**. Mr. Christopher A. Nissen, the National Program Manager of the 287(g) Program expressed his appreciation of the FIRE Coalition's interest in promoting the 287(g) Delegation of Authority Program and forwarded our inquiries to the Special Agent in Charge in New Orleans.

View the yearbook pages included in this report. They represent just a portion of the families torn apart by the failure of our federal, state, and local governments to protect them against this invasion. Look in the eyes of the women and children killed by illegal aliens. Look into the eyes of the families that lost more than one person to violent crime or the negligence of illegal aliens. If seeing American families destroyed and women and children killed aren't enough, look into the eyes of your fellow law

enforcement officers who aren't here anymore because they too, died at the hands of illegal aliens.

The largest invasion in the history of the world must stop. State governments are constitutionally bound to help protect the legal citizens of the United States. Every time the United States has granted some form of amnesty, the flood of illegal aliens clamoring across our southern border has gone up. The deaths of 25 Americans per day were not enough for many state governments to be considered worth a single phone call or email. Were you one of them? Do you think your family is immune from this tragedy? Contact any of the 3000+ victims listed in the "For Whom the Bell Tolls" Report, or any of the victims included in the yearbook pages of FIRE's "30 Pieces of Silver" report and ask them how immune they feel to the tragic death of a family member at the hands of an illegal alien. Ask them would they rather protect the financial interests of big business or a winery owner, or would they prefer to have their son or daughter back? Ask yourself next time you find a mirror staring back at you what you'll tell your spouse when one of your children dies at the hands of an illegal alien. There's not a cheap head of lettuce or glass of wine from Speaker Pelosi's vineyard that will make that conversation palatable.

Elected officials are required by their oath of office to uphold and defend the Constitution of the United States. Members of the 110th Congress are taking that oath today. Members of Congress willingly and knowingly will swear to God to do just that. The legitimate citizenry of the United States has the right to expect NO less. A promise is a promise; an oath an oath.

The opportunity for the 110th Congress and for all the state legislatures convening in the coming months to represent "we the people" is tremendous. The opportunity to restore the faith of "we the people" that we are represented, and to restore the integrity of our halls of government is now.





CRIMINAL ALIEN STATISTICS

Summary: On average each day 25 Americans die at the hands of criminal aliens in the United States. Twelve Americans are murdered by criminal aliens. Another ten Americans are killed by drunk-driving criminal aliens. Finally, an additional three Americans will die because of negligent homicides by criminal aliens, such as running a red light, speeding, or the negligent handling of a dangerous weapon.

Murder - The willful (non-negligent) killing of one human being by another. This includes first and second-degree murder, as well as non-negligent manslaughter. Murder does not include deaths caused by negligence, suicide, or accident; justifiable homicides; attempts to murder or assaults to murder, which are considered “aggravated assaults.”

Negligent Homicide - Negligent homicide is the killing of another person through gross negligence or without malice. It can also be considered a death that is the result of the negligent operation of a motor vehicle, which includes the operation of a car, boat or snowmobile.

Source: Iowa Representative Steve King (IA-5) first brought these alarming statistics to our attention earlier this year. Recently, Congressman King was the guest of Bill O’Reilly who had asked the Iowan come on his show to discuss his findings in greater detail.

Statistics:

Criminal Alien Prison Population –

According to an April 7th, 2005 General Accounting Office (GAO) study entitled, “*Information on Criminal Aliens Incarcerated in Federal and State Prisons and Local Jails*” [Report # GAO-05-337R] prepared for the Congressional Subcommittee on Immigration, Border Security, and Claims:

“27% of the total population in all U.S. prison systems (including city, county, state and federal) is composed of criminal aliens.”

Total Murders in the U.S. in 2005 –

According to the FBI, there were 16,692 persons murdered in the U.S. in 2005. The Uniform Crime Reporting Program defines murder and non-negligent manslaughter as the willful killing of one human being by another.

Total Drunk-Driving Fatalities in the U.S. in 2005 –

According to the National Highway Traffic Safety Administration, 12,945 Americans were killed in car crashes where the driver had a blood alcohol concentration of .08g/dL or higher in 2005.

Calculations:

Total number of people murdered in the U.S. at the hands of criminal aliens in 2005: **4,507**

This number is calculated by taking 27% multiplied by the total number of murders in the U.S. in 2005 ($.27 \times 16,692 = 4,507$)

This figure equals approximately **12 murders every day** at the hands of criminal aliens ($4,507 / 365 = 12$)

Total number of people killed in the U.S. as a result of drunk-driving criminal aliens in 2005: **3,495**

This number is calculated by taking 27% multiplied by the total number of alcohol-related fatalities in 2005 ($.27 \times 12,945 = 3,495$)

This figure equals approximately **10 deaths every day** at the hands of criminal alien drunk drivers ($3,495 / 365 = 10$)

Conclusions:

Twenty-five Americans die at the hands of criminal aliens every day in the U.S.

(12 murders + 10 drunk-driving fatalities + 3 negligent homicides = 25 deaths every day)

In the year 2005, criminal aliens killed more than three times the number of Americans murdered in the terrorist attacks of 9-11 died.

9,125 Americans died at the hands of criminal aliens in 2005, as compared to approximately 3,000 Americans who perished in 9-11.

Federal prison criminal alien population:

Total number of criminal aliens in federal prison: 48,708

Mexico 63%, Colombia and Dominican Republic 7% each, Jamaica 4%, Cuba 3% and El Salvador 2%, remaining countries represent less than 2% each.

Top 5 State prisons system criminal alien population:

Total number of criminal aliens in top 5 states' prison systems: 51,600

Mexico 58%, Cuba and Dominican Republic 5% each, El Salvador 4%, Jamaica 3%, remaining countries represent less than 3% each.

Top 5 local jails' criminal alien population:

Total number of criminal aliens in top 5 states' prison systems: 170,000

Mexico 65%, El Salvador 6%, Guatemala 3%, remaining countries represent less than 3% each.

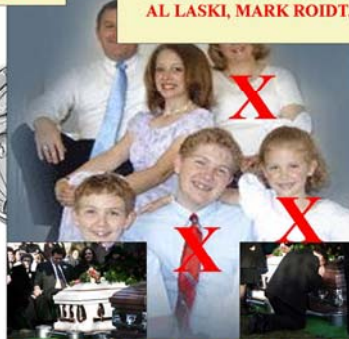
